

RV Storage Waitlist

Due to high demand, there is a waitlist for RV Storage sites. Please place yourself on the waitlist to be notified when a site is available.

Waitlist entries are prioritized by the following categories:

Priority 1: Active duty military members residing in SAFB government quarters

Priority 2: Active duty military members assigned to SAFB (w/in 50 miles) and residing in off-base housing

Priority 3: Active duty military members assigned temporary duty (TDY) at SAFB, but only for the TDY period. Reserve members.

Priority 4: Retired military members , DoD, APF, and NAF civilian employees assigned to SAFB (living w/in 50 miles)

The on-base RV Storage lots are managed by Scott AFB Outdoor Recreation. There are 3 lots available for storing RVs and trailers up to 40ft.

Lot 1 is located next to the Outdoor Recreation building. Lot 2 is also on East Drive, beside the firing range. Lot 3 is located near the Thrift Shop and Security Forces buildings on South Drive.

All lots offer a fenced-in, paved lot with assigned sites and 24/7 access. All lots have a padlocked gate.

All individuals must have valid DoD card to utilize any service or facility of Outdoor Recreation

RV Storage Rules

- Only (1) item allowed per site.
- RV Storage account must be in the name of the RV/trailer owner.
- All stored property must clearly display current registration (plates, decals, etc.).
- Registered trailers/campers and site must be well maintained by customer. Stored items must be in good working condition.
- All stored items must be properly chocked.
- No habitation of recreational vehicles while stored in the RV lots.
- Autos and other passenger vehicles must not be stored in sites unless they are loaded on a car hauler and properly covered.
- Vehicles may not be parked in the site while item is out; only the item registered for the site may be stored there.
- No portable fuel containers are allowed in the space.
- RV/trailer maintenance is not permitted while parked in the lot. This does not include departure preparation such as servicing tires, cooling system or fluid check, wiper replacement, etc.
- If swapping the item stored, new registration and insurance must be provided.

Additional rules for storage apply. Failure to comply will result in removal.

Rates

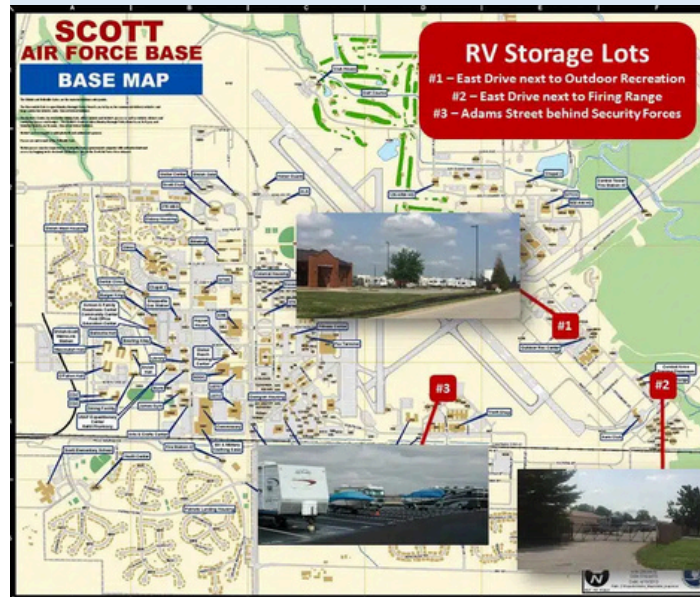
Short Sites (≤20ft): \$27/month
Long Sites (21-40ft): \$37/month

Rental fees are processed monthly via autopay. Agreement for a monthly automatic debit of a credit/debit card is required for issuance of a storage site, no exceptions.

Requirements

Upon accepting offered RV Storage site, customers must schedule an appointment to set up account. At appointment, customers must present:

- Registration of RV/trailer in customer name
- Proof of insurance for item or POV insurance if covers items towed
- Proof of living w/in 50 miles or on base
- Military ID/CAC
- Picture of item to be stored



Eligibility

Only the following categories of customers are authorized to use the RV storage lot in the listed priority. NOTE: The Installation Commander has the authority to change the priority procedures without notice when ensuring force protection conditions are complied with.

1. Active duty military members residing in SAFB government quarters
2. Active duty military members permanently assigned to SAFB (within 50 miles) and residing in off-base housing
3. Active duty military members assigned temporary duty (TDY) at SAFB, but only for the temporary duty period. Reserve members.
4. Retired military members, DoD APF and NAF civilian employees assigned to SAFB (within 50 miles)

The following items are permitted to be stored within the RV Lots:

- Enclosed trailers
- Utility/landscape trailers
- Tow-behind campers
- RVs
- Horse trailers
- Boats (on trailers)
- 5th wheels
- Car haulers
- Motorcycle trailers

Personal vehicles are not permitted to be stored in the RV Storage Lots.
