Rate

POV Permit

Permit required to place vehicle on POV Resale Lot. POV Permit is good for 30 days from date of purchase. Permit may be renewed for a second 30 day period if vehicle does not sell within first 30 day period. At the end of the second 30 day period, vehicle must be removed for 30 days before beginning the process again. Customer is responsible for providing a current picture of the vehicle for the online listing.

Documentation

To purchase a POV Permit, customer must bring in the following *valid and current* documents: Proof of Insurance and Proof of Registration (vehicle must be registered in the name of present person purchasing permit, or must have Power of Attorney). A valid DoD ID is required.

POV Placard

A placard will be provided to the customer that must be prominently displayed on the vehicle to be sold while it is placed on the POV Resale Lot. Placard will be dated with the permit expiration date.

Website

Vehicle will be listed on the POV website, located at

www.375fss.com/IO/ODR/POV-Resale.php Listing will include details from POV Permit as well as a picture of vehicle provided by customer. Vehicles will be displayed until the ad expiration date is reached, when the ad is automatically removed. Owners who sell their vehicles or remove them from the sales lot must inform Outdoor Recreation of the change, so the vehicle can be removed from the website.

Selling

Outdoor Recreation is not responsible for contacting the seller or potential buyers. Sellers of motorcycles, motor scooters, and mopeds will not permit untrained potential military buyers to test drive the vehicle. Potential military drivers must provide proof of training (eg. Motorcycle Safety Foundation Card, or letter from the safety installation stipulating individual's licensing state has been approved by the Motorcycle Safety Foundation) before test driving the vehicle.

POV Lot

The POV Resale Lot is located on East Dr past the Veterinary Clinic and before the Railroad tracks on the south side of the road. Vehicles must be placed in a valid parking spot within the lines of the spot. Vehicle must be kept in good condition while placed on the POV Lot and must not be allowed to fall into disrepair. No onsite maintenance is allowed while the vehicle is in the lot. POV Resale Lot is for the selling of vehicles only and is not to be used for storage. Only the item registered for POV may placed on Lot.

CUSTOMERS WITH VEHICLES LEFT ON THE LOT PAST THEIR PERMIT TIME PERIOD WILL BE CHARGED \$15 FOR EVERY ADDITIONAL MONTH THE VEHICLE IS LEFT ON THE POV LOT UNTIL REMOVED BY OWNER.

Items for sale in the POV Lot must not be inhabited while in the Lot. Sleeping and other related activities are not allowed in the POV Lot.
