

Pavilions Overview

Schedule your family or group gathering through the Outdoor Recreation program with the rental of a pavilion. There are numerous pavilions to choose from:

Pavilion 2 south of Scott Lake
Pavilion 4 north of Cardinal Lake
Pavilion 5-10 west side of Warrior Park
Pavilion 11 north side of Warrior Park

All pavilions have picnic tables, trash cans and charcoal grills. Pavilions 1, 2, 4 and 11 have water and electric. Pavilions 1, 2, and 4 have horseshoe pits.



Additional Services

FamCamp (additional regulations apply)

Pavilion 11	\$35/day

Reservations

Reservation and payment is required for Pavilion usage. Pavilions may be reserved at any time during the current calendar year. A reservation card will be placed at the chosen pavilion for your reservation date. Reservation time period starts at 0800 and ends at 2230. Trash cans are available for pick up from Outdoor Recreation.

Cancellations

All cancellations must be made 48 hours prior to pavilion reserved date to receive a full refund. If cancellation is less than 48 hours, it will be non-refundable. Cancellation due to military commitment will be refunded 100%, as long as you are able to show memorandum or proof of orders.

Cleanup

At the end of usage, all picnic tables must be returned to their original configuration under the pavilion and grills must be cleaned out. Do not leave any trash or debris at the pavilions. Empty and clean trashcans must be returned to Outdoor Recreation during business hours.

Alcohol Consumption

Unit commanders may approve serving/consumption of alcohol within their assigned unit facilities. "Serving" is defined as the consumption of alcohol that was not provided by the individual themselves. Additionally, unit commanders may approve the serving/consumption of alcohol at the following designated installation areas during unit commander sponsored events. Commanders must ensure unit personnel comply with DAFI 34-219, Alcoholic Beverage Program, to include dram shop training, transportation plan and remain primarily responsible for the safety of all Airmen and their guests who attend this event where alcoholic beverages are served when approving the serving/consumption of alcohol at sponsored events:

- Athletic fields
 - Base picnic areas
 - Flight line (Fini-flights)

Picnic Areas

Non-reservable picnic areas in the Scott Lake Recreation area beside the front lake are available on a first come, first serve basis only. Do not leave any trash or debris at the picnic areas.

Pavilion 11 (Warrior Park Pavilion)

Reservation of Pavilion 11 (Warrior Park Pavilion) does not include reservation of the playground area or the Warrior Park. Bathrooms are located at the Softball Fields with access managed by the Fitness Center. Please contact Fitness Center (256-1218) to confirm bathroom availability.
