

## RV Storage Waitlist

To receive a site in one of the RV Storage Lots, you must first place your name on the RV Storage Waitlist.

To place your name on the RV Storage Waitlist, go to <https://375fss.com/outdoor-recreation/join-waiting-list/>

Read through the Eligibility List to determine which category fits your status and then select the link **“Add your name to the Waiting List”**. Please answer all questions.

To see where you are on the Waitlist, select the link **“Check where you are on the list”** on the above listed website.

Customers will be contacted when a site becomes available based on their placement on the Waitlist.

### Eligibility Priority Status

1. Active duty military members residing in SAFB government quarters.
2. Active duty military members permanently assigned to SAFB (within 50 miles) and residing in off-base housing.
3. Active duty military members assigned temporary duty (TDY) at SAFB, but only for the temporary duty period.
4. Retired military members, DoD APF and NAF civilian employees assigned to SAFB (within 50 miles).

## Additional Services

### FamCamp (additional regulations apply)

- RV Site (water/electric) \$25/day
- Overflow (no utilities) \$10/day
- Primitive/Tent (no site) \$10/day

### Scott Lake Fishing Permits

- Individual \$5/year
- Family \$7/year

### Picnic Pavilions

- Pavilions 2, 4-10 \$15/day
- Pavilion 11 \$35/day

### POV Resale

Permit required \$15/30 days

## Overview

Outdoor Recreation offers Recreational Vehicle (RV) storage for items up to 40 ft. long in 3 separate lots. Lot 1 is located next to Outdoor Recreation, Bldg. 3176, Lot 2 is down the street east of the firing range (on East Drive) and the Lot 3 is located near the Security Forces Building. All lots offer a fenced-in, paved lot with assigned sites and 24/7 access. Access system is a padlocked gate. Active Duty personnel living on SAFB, Active Duty living off base, Retirees, and DoD civilians are eligible.

## Rates

\$27/month for a short site (20 ft or less)

\$37/month for a long site (up to 40 ft)

## Payment

Site Rental Fees are due monthly, and must be paid in advance. All payments are automatically deducted from a credit card the first day of each month. Agreement for a monthly automatic debit of a credit/debit card account is required for issuance of a storage site. No waivers.

## Registration

The site registration must be in the same name as RV/vehicle owner. At the time of issue of a site, proof of ownership and title, up-to-date state vehicle registration, proof of insurance, and local contact address and telephone number must be provided. Insurance and registration must be maintained for the entire period item is stored.

## Storage Requirements

- Only one (1) item allowed per site.
- All stored property must clearly display current registration (plates, decals, etc).
- Registered trailers/campers and site must be well maintained at all times by customer. Stored items must be presentable and in good working condition.
- All stored items must be properly chocked.
- *Items stored in the RV Lots must not be inhabited while in RV Storage. Sleeping and other related activities are not allowed in the RV Lots.*
- Autos and other passenger vehicles must not be stored in the sites unless they are loaded on a car hauler and are covered properly.
- Vehicles may not be parked in the site while item is out; only the item registered for site may be stored in site.
- Motor vehicles and boats aren't permitted to have engines run inside the storage space except upon entry or departure.
- No portable fuel containers are allowed in the space.
- Fuel tanks must not have any leaks.
- No smoking is allowed in any enclosed storage spaces.
- Interior walls and floors must be protected from oil or spills.

Additional requirements apply. Failure to comply with policies will result in removal.

## Maintenance

Housekeeping on the site must be maintained at all times. Vehicle/camper maintenance is not permitted while the vehicle or camper is parked in the lot. This does not include departure preparation, such as servicing tires, cooling system or fluid checks, lamp or wiper replacements, etc.

## Vacating RV lot

When you are ready to permanently vacate your RV site, please contact Outdoor Rec by calling (618-256-2067) or stopping by Building 3176 once your item is removed and your site is cleared. This will ensure all the proper paperwork is complete and you are not charged further.
