What is POV Resale?

POV stands for Personally Owned Vehicle.

If you have a vehicle you want to sell, this is the place to do it!

Rate: \$15 for 30 days

All individuals must have valid DoD card to utilize any service or facility of Outdoor Recreation

POV Permit

A permit provided by Outdoor Recreation is required to place the vehicle on the POV Resale Lot. POV permit is good for 30 days from date of purchase. Permit may be renewed for a second 30 day period if the vehicle did not sell.

At the end of the second 30 day period, the item must be removed from the POV lot for a minimum of 30 days.

Customer is responsible for providing a current picture of the vehicle for the online listing.

Documentation

We require the following for vehicles to be placed on our POV Lot:

- Proof of Ownership
- Proof of Insurance - must be current
- Proof of Registration- must be current

Insurance and registration must be maintained for the duration of the time the item is on the POV Lot.

Documents MUST be in the name of the person purchasing the permit or they have a Power of Attorney.

What the \$15 fee Gives You Placard:

Outdoor recreation will provide a placard to go in or on your vehicle. This is a required to be displayed while actively parked on the POV Lot. The expiration date will be written on the placard itself.

Website:

Outdoor Recreation will also post your vehicle on our 375fss.com website. Will place the vehicle and seller information as well as picture on our website.

Vehicles will be displayed on our website until the ad expiration date has been reached.

Owners who sell their vehicles or remove them from the lot need to inform ODR of the change so we can remove the vehicle from our website early if needed,

POV Lot:

It is located on East Dr past the Veterinary Clinic and before the road. Vehicles must be placed in a parking spot and kept in good condition. No onsite maintenance of vehicles is allowed on the POV Lot.

POV Resale Lot is for the selling of vehicles only and is not to be used for storage. Only the items registered for the POV may be parked in that area.

Selling Your Item

Outdoor recreation is not responsible for contacting the seller or protentional buyers.

Sellers of motorcycles, motor scooters and mopeds will not be permit untrained potential military buyers to test drive the vehicle. Potential military drivers mist provide proof of training (i.e. Motorcycle Safety Foundation Card, or letter from the safety installation stipulating individual's licensing state has been approved by the motorcycle safety foundation) before test driving the vehicle.

Items for sale in the POV Lot must not be inhabited while in the lot. Sleeping and other related activities are not allowed in the POV Lot.

CUSTOMERS WITH VEHICLES LEFT ON THE LOT PAST THEIR PERMIT TIME PERIOD WILL BE CHARGES \$15 FOR EVERY ADDITIONAL MONTH THE VEHICLE IS LEFT ON THE LOT UNTIL REMOVED.

SECURITY FORCES WILL BE CALLED IF VEHICLE IS NOT REMOVED IN A TIMELY MANNER OR OWNER IS UNABLE TO BE REACHED.
